

## **Raffle ticket rules & regulations**

#### **1. Raffle**

The raffle opens on February 23, 2024, and ends on Saturday, June 1<sup>st</sup>, 2024, at 9:30pm. Any reference to the rules regarding the time refers to Eastern Daylight Time (EDT). Prize draw will take place Saturday, June 1<sup>st</sup>, 2024, at 10:00pm at the D4S evening event at 40 Westt Steakhouse, 2305 Trans-Canada Hwy, Pointe-Claire, Quebec H9R 5Z5.

#### **2. Eligibility**

The Raffle is open to all residents of Quebec aged eighteen (18) years and over, except employees, agents and / or representatives of D4S or Starlight Canada, or advertising and promotion agencies, suppliers of prizes, material and services related to this Raffle, as well as members of their immediate family (brothers, sisters, children, father, mother), their legal or common-law spouse, and any person with whom these employees, agents and representatives are domiciled, even if they are not members of the same family.

## **6. Entry Deadline:**

Completed purchases up to Saturday, June 1<sup>st</sup> 2024 at 9:30pm are eligible to be entered into the draw.

Starlight Canada will advise the winner on site at the D4S event on Saturday, June 1<sup>st</sup>, 2024. Should the winner be unable to attend the event, we will call them to inform them that they have won. In the event Starlight Canada fails to notify a winner within a period of five (5) days from the draw date, an additional draw will be conducted to determine an alternate winner.

Any incomplete, incomprehensible, obtained or improperly completed form or a form from an unauthorized source will be automatically rejected and will not be entitled to any prizes. In addition, any participation or attempted entry which is in breach of this Regulation (e.g. misrepresentation of a participant, breach of intellectual property requirements, etc.) will be automatically rejected and may be referred to a competent judicial authority.
